3. Enter your name, birthdate, the last four digits of your Social Security number, and your ZIP code, then choose **CONTINUE**.
4. Select **Retirement plan account**, then **CONTINUE**. We'll text or call you with an authentication code to verify your identify and set up two-factor authentication (TFA). The next time you log in, you can select **Remember this device**. If you do, you won't need to complete TFA on that device for 30 days.
5. Once verified, create a username and password to log in.
